Honble Lt. Governor, A&N Islands has been pleased to constitute a committee comprising of the following as members to oversee the activities of fraud and fake companies/ Institutions coming over these islands for placement / recruitment of local youth and offering lucrative jobs and admissions to various mainland institutions etc.

The Committee shall have a watch over such fraud agencies coming over to these islands and shall preferably meet once in three months. If any institutions come to these islands for recruitment of island youth for higher education, job etc, it has to approach the Director of Education and he has to verify the authority, reliability of the institutions before allowing them to publish their advertisement conducting the recruitment examination etc after obtaining the approval of the Principal Secretary (Edn)

The Director IP&T shall issue a press note to all local publications/dailies, Press & media that they shall accept such advertisements only after they produce the clearance from Pr. Secretary (Edn), A & N Administration.

The Director General of Police and the Superintendent of Police (Anti Corruption) unit shall monitor the activities of such institutions and any one found involved in fraud and fake activities in offering lucrative jobs, admissions etc. shall be proceeded under the law.

The Director of Education being the Member Secretary has to frame necessary draft guidelines for preventing all the illegal activities of fake /fraud companies /institutions offering jobs, training etc., within one month. The draft regulation shall be placed before the Hon'ble Lt. Governor for approval. The Chairman of the Committee shall frame any other Orders / directions as required in monitoring the activities of such fake institutions/companies etc.
